### MAYOR:

Mayor Mazzari had nothing to report.

### **PLANNING:**

Ridgeway reported Jason Snively from Danville Schools and Leo Dueck, owner of Don Leo's was present. He is looking into building an 80'X80' building on the old Ed McClain property that he has recently acquired. The current Don Lea's will stay mostly as is with fresh produce. The new building will allow him to expand his other inventory. He is asking for the street to be vacated, as it has never been used as a street. McClain had a couple of sheds setting on this. Stachler said there is a sewer line that runs there. Planning Committee said they would have to look into this before they will have an answer.

Snively was in attendance with final plans from his Architect for the School Parking Lot. Water drainage throughout the lot to filter down to the Village storm drain. Lighting on each side of the lot. Ridgeway reported a letter has been sent to all adjoining property owners. They have been invited to a Public Meeting to be held on Wednesday, July 30, 2025 at 6″00 p.m. in the Village Conference Room at 512 S. Market Street.

Mt. Vernon City is working on updating their inoperable/junk vehicle laws. It was suggested for us to get a copy of their new restrictions, when they have completed them. Mickley feels that Mt. Vernon's inoperable/junk vehicle laws are too strict.

### **ZONING:**

Chase and August Law have taken possession of 14799 Millersburg Rd. Ridgeway went on to report that Chase and August Law along with Barb Banbury will be at the next Planning meeting scheduled for August 11, 2025.

### STREETS:

Mickley reported, he has talked to many people, Amish and English, about the horse manure in the Village. Mickley feels we need to meet and talk together to find a solution. Mickley proposed to invite some Amish to a Planning Meeting to discuss this.

We still need to work on legislation to cover the damage to our streets due to the traffic on our streets from new building within the Village.

#### PARK:

Byers reported the new fence and sidewalk along Tough Street at the football field looks very nice. She feels the new link fence put up on the south side of the field has taken more from the playground area than she thought it would. She is concerned about the less space and safety. Durbin agreed the fence does intrude on the Playground area. Durbin has had concerns about this project since the beginning. The piles of dirt taken off the field in preparation for the turf, belongs to the Village.

### **SOLID WASTE:**

The Fall Clean Up Day was approved by Council. It will be from September 29<sup>th</sup> through October 3<sup>rd</sup>. the dumpsters will set out back of the Municipal during this time and available 24/7 during this week. There will be assistance in unloading from 8:00 a.m.- 4 p.m. you just have to ask. The fee is still \$20.00 per truckload and \$20.00 per trailer load. Payments will be collected inside at the Clerk's office during 8-4 and can be placed in the drop box after 4:00 p.m. A reminder: tires, paint and accelerants are not accepted and this area will be under surveillance during this time.

Durbin also reported a printer, a car seat and a screen are laying outside of the Recycle Dumpsters. Danville is in line to get a concrete slab for under our Recycle Bins. We have been approved for 2 or 3 more dumpsters.

### **TECHNOLOGY:**

Crow had nothing to report. Vance has found out that Alpha Link cannot support the scanning of old documents onto a flash drive. Durbin is wondering if maybe we need to think about a new IT Company that can support this.
