OTHER BUSINESS:

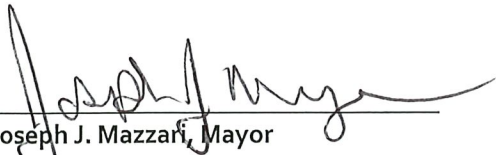

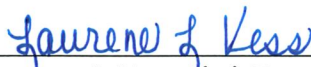
