VILLAGE OF DANVILLE COUNCIL met in regular session on Monday, December 15, 2025 in the Council Chambers. Mayor Mazzari called the meeting to order at 6:08 p.m. Roll call was taken as follows; Jill Byers; present, Deb Ridgeway; present, Patrick Crow; present, Darin Durbin; present, Amanda Strouse; present and Jeff Furay; present.

PRESENT:

Also present; Joel Stachler; Administrator and Laurene Vess; Clerk-Treasurer.

PLEDGE OF ALLEGIANCE:

Mayor Mazzari led the Pledge of Allegiance.

MINUTES:

A motion to approve the minutes to the December 1, 2025 meeting, was made by Ridgeway and seconded by Byers. Voice vote; all yes

PUBLIC PARTICIPATION:

Guests were present to celebrate the retirement of Jill Byers after 26 years of service to the Village on Council and the retirement to Laurie Vess as Clerk-Treasurer for 25 years. Cake and drinks were served. Mayor Mazzari thanked both for their years of service to the Village of Danville.

OLD BUSINESS:

Mayor Mazzari reminded Council members that they will have 30 days to appoint council seats, Byers, Furay, Strouse.

NEW BUSINESS:

Mayor Mazzari introduced Bailey White, who has been hired as the Fiscal Officer, an appointed position to replace Laurene Vess, retired Clerk-Treasurer. White is Fiscal Officer for Union Township and recently the Village of Brinkhaven. A motion was made by Ridgeway and seconded by Strouse to begin paying White on 12/29/2025. Roll call; Byers-yes, Ridgeway-yes, Crow-yes, Furay-yes, Strouse-yes and Durbin-yes.

The open Bidding process for Cottrell Park closed on 12/10/2025. We should hear the results soon.

LEGISLATION:

ORDINANCE 2025-12 To Establish Parking Fines Within the Village, was given a final reading. A motion was made by Durbin and seconded by Ridgeway to adopt Ordinance 2025-12 as presented. Roll call; Byers-yes, Ridgeway-yes, Crow-yes, Furay-yes, Strouse-yes and Durbin-yes.

RESOLUTION 2025-10 To Authorize/Sign for 2022 Truck Loan at Park National Bank. A motion to declare an emergency and to suspend the rules requiring it to be read on three separate occasions and to bring it forth to a third and final reading was made by Crow and seconded by Ridgeway. Roll call; Byers-yes, Ridgeway-yes, Crow-yes, Furay-yes, Strouse-yes and Durbin-yes. A motion to adopt Resolution 2025-10 as presented was made by Ridgeway and seconded by Crow. Roll call; Byers-yes, Ridgeway-yes, Crow-yes, Furay-yes, Strouse-yes and Durbin-yes.

White asked about purchasing an AI tablet to record and type the council minutes. The cost is around \$550.00 and includes storage.

WATER/WASTEWATER:

Furay reported there was a waterline break over the weekend, possibly broken when the Fire Department Shut a water hydrant too fast.

Another load of scrap was hauled away to Ross Bros from the Waste Water Treatment Plant and we received a check for \$581.20.

The electrician should have electric at the WTP and WWTP gates next week.

FIRE:

Durbin reported the Fire Board accepted a grant for the MARX Radios and Repeaters in the vehicles, \$40,741.70.

November runs were 133 and Year to Date= 1,488. Up 66 runs from this time last year.

POLICE:

SAFETY SERVICE DIRECTOR:

MAYOR:

Mayor Mazzari had nothing to report.

PLANNING:

Nothing to report. No meeting until January 2026.

ZONING:

STREETS:

Durbin asked when next year is ODOT planning on paving through Danville. Joel Stachler, Administrator will connect with Kyle Hughes will try to get a begin date and a copy of the list of plans. We would like to have the Waterline Project finished before they pave. Project should go to bid February or March.

Mitch Durbin from Main, Market and Beyond has \$5,500 not being used for the stage. Suggestions include; metal benches, replace fence along Tough Street.

SOLID WASTE:

TECHNOLOGY:

Durbin asked about considering a cloud-based system versus purchasing another traditional PBX type system.

ADMINISTRATOR:

Stachler reported our two trucks have sold through **Municibid**. The 2005 sold for \$5,100 and the 2000 sold for \$800.
