

Ordinance 2026-5

AN ORDINANCE TO AMEND 2026 APPROPRIATIONS AS PASSED BY THE COUNCIL OF THE VILLAGE OF DANVILLE, STATE OF OHIO, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Danville, Knox County, Ohio; the 2026 sums be hereby amended as follows;

Section 1 That there be additional appropriations in the Fund as follows;

General Fund	1000-730-352-0000	Property Insurance	\$15,000
Street Fund	2011-620-352-0000	Property Insurance	\$1,500
Park Fund	2041-310-352-0000	Property Insurance	\$500
Water Fund	5101-533-352-0000	Property Insurance	\$2,500
Sewer Fund	5201-542-352-0000	Property Insurance	\$2,500

Section 2: That Ordinance 2026-5 as enacted on the 4 day of May 2026 and all its amendments be hereby adopted.

Section 3: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety and for the further reason that an emergency exists in the usual daily operation of the various departments of the municipal government and further that this Council deems it imperative that immediate action be taken to insure the continued usual daily operation of the various departments of the municipal government, and said Ordinance shall, therefore become effective upon its date of passage, provided that it receives the affirmative vote of two-thirds of the members elected to Council of the Village of Danville, otherwise, it shall take effect and be in full force from and after the earliest period allowed by law.

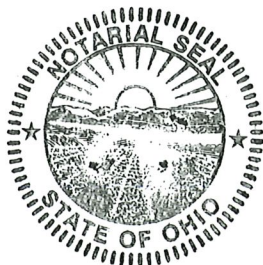
