**VILLAGE OF DANVILLE COUNCIL** met in regular session on Monday, March 3, 2025 in the Council Chambers. Mayor Mazzari called the meeting to order at 6:05 p.m. Roll call was taken as follows; Jill Byers; present, Deb Ridgeway present, Patrick Crow, present, Darin Durbin, present, Scott Mickley, present and Jeff Furay, present.

Finance Meeting is scheduled for Saturday, March 15, 2025 at 8:00 a.m. We need Joe Mazzari, Monte Vance, Joel Stachler, Jeff Furay and Tina Durbin are asked to attend to discuss Permanent Appropriations for 2025.

**PLANNING:**

Ridgeway reported the next Planning meeting is scheduled for Monday, March 10, 2025 at 6:00 p.m. They plan to discuss Tap Fees

**ZONING:**

Bender reported a red car has been parked at the corner of Walnut and Cedar Streets. There is a couch outside in the yard of a couple of places in the Village.

**STREETS:**

Stachler reported he has been looking for a Street Sweeper to purchase. In the meantime, he assured council he would be using what we have to clean the streets. Stachler has been talking with Main Market and Beyond if this could be included in their Beautiful Grant. Serilda Street should be opening up in 2 or 3 weeks. It will cost \$8,778.50 plus installation to replace the street lamp that was run into. A police report was made and their insurance company has been sent the quotes.

**PARK:**

Byers reported the playground equipment has been installed. The muddy areas are being worked on. The village need to run a new storm sewer with a catch basin around the playground. The school is putting a catch basin inside the fence on the Southwest corner.

Mickley thanked Joel Stachler, Ricky Talbot and Robert Shipley for helping the Athletic Boosters locate the water and sewer lines within the fence area.

Pine trees are down behind the Memorial. Stumps to be removed, the ground leveled and Sugar Maple trees will be planted. Would like to see a white fence to replace the split rail fence along Tough Street at the Memorial. Main Market and Beyond talked about fencing if there is any money left from the grant.

**SOLID WASTE:**

Crow reported he has reached out to Rob Bower by phone. He has not called back. Crow plans to email him about getting a couple more recycle bins. Is DKMM still planning on putting a concrete slab under the recycle ins?

**TECHNOLOGY:**

No report.

**ADMINISTRATOR:**

Stachler reported he has found a Bucket Truck for \$25,000.00. this would be used for many things we are hiring to be done currently like hanging banners, baskets, flags, Christmas lights and trimming trees. A motion was made by Byers and seconded by Mickley to authorize the Clerk to use Park National Funds to pay for the truck. When Permanent Appropriations are approved and passed the money will be paid back as follows; General Fund \$6,250, Street Fund \$6,250, Water Fund \$6,250 and Sewer Fund \$6,250. Roll call; Byers-yes, Ridgeway-yes, Crow-yes, Furay-yes, Mickley-yes and Durbin- yes.

Stachler informed council all Village trucks have the Village on them. Vance and Stachler are working on the Maintenance inventory.
